

4. It may also be noted that **Rs 65 Cr** was approved for KIYG 2023 and KIUG 2023 both in the **39<sup>th</sup> DPAC** meeting dated **27.7.2023**. Further, the Head-wise expenditure is proposed in the above-mentioned table (*Columns 3 & 4*).

5. It is submitted that preparing the estimate of Khelo India Winter Games 7 sports have been taken into consideration, however if the number of sports discipline gets reduced the estimate will also reduce accordingly and the same shall be placed before DPAC for its information. Further, the estimated budget for Khelo India Winter Games also includes likely expenditure to be incurred on Accommodation, Catering & Transport.

- 6. In view of the above, the following are placed before DPAC for necessary direction
  - Broadcasting and Production along with monetizing rights may be given to the Host State in case of Khelo India Youth, University, & and Winter Games. Accordingly, the estimated expenditure will get reduced.
  - **KIWG 2024 :** The Financial liability for the Khelo India Winter Games may be distributed among the Host State and SAI. Host UTs may be asked to bear the expenditure for Accommodation, Catering & Transport and in that case the estimated expenditure will also get reduced accordingly.

# Approval of the DPAC is solicited for:

- i. Approval for the estimated budget of Rs. 103.8 crores towards Khelo India Games (KIYG 2023, KIUG 2023, KIPG 2023, KIWG 2024) to be debited under the "Sports Competition and Talent Development" Vertical of Khelo India.

Subsequent to the letter recived from the Sports Authority of India for the production and telecast of the games, DD Sports team did the recce of the different venues as per the proposed schedule of the event as shared by your team.

Accordingly, the media plan with the following broader cantour is being proposed:-

1. DD Sports received a proposal from the Sports Authority of India wherein it requested for the coverage of the inaugural edition of the Khelo India Para Games in New Delhi. The Games are scheduled in the three different venues of Delhi from 10th December to 17th December, 2023.
