

Now DPAC has decided that without allocation of any additional fund, SAI may utilize the limit of Rs 34.01cr from already allocated Rs 35.19cr for procurement of sports science equipment's for the purpose of upgradation of target systems in qualification ranges of 10m, 25m, 50m and 7 trap & skeet ranges. Overall allocation in this component should be limited to 46.91 cr. |
